2. THIS ANNOUNCEMENT PROVIDES AN UPDATE TO MILPER MESSAGE 14-313, DATED 22 OCT 14.

3. PARAGRAPH 3 IS AMENDED TO READ:

3. ELIGIBILITY CRITERIA: ALL USAR AGR SFC WITH A DATE OF RANK (DOR) OF 11 FEB 11 AND EARLIER, A BASIC ACTIVE SERVICE DATE (BASD) OF 10 FEB 90 AND LATER, AND WHO POSSESS A PRIMARY MILITARY OCCUPATIONAL SPECIALTY (PMOS) IDENTIFIED BELOW: 11B, 12B, 12H, 12N, 13B, 19K, 25U, 88K, 88U, 92A, AND 92M. ALL OTHER PMOS WILL NOT BE CONSIDERED.

4. PARAGRAPH 4 IS AMENDED TO READ:

C. SFC WHO DO NOT POSSESS A PMOS ANNOUNCED IN PARAGRAPH 3 ABOVE.

ADDITIONAL MOS MAY BE REMOVED FROM QSP CONSIDERATION WHEN DICTATED BY OUT-OF-CYCLE STRUCTURE CHANGES.

D. RA SFC WILL NOT BE CONSIDERED FOR QSP WITH THIS BOARD. A FUTURE MESSAGE WILL BE RELEASED ANNOUNCING THE CRITERIA AND DATES FOR THE NEXT RA SFC QSP BOARD.

5. PARAGRAPH 5 IS AMENDED TO READ:

G. IF SELECTED FOR SEPARATION UNDER THE QSP, AGR SFC MAY BE ELIGIBLE TO REQUEST RECLASSIFICATION AS AN EXCEPTION TO POLICY IF OTHERWISE QUALIFIED.
